**Dealing in Proceeds of an Unlawful Activity:** This refers to laundering money gained through illegal activities such as drug dealing. This offense is a first degree felony.

#### Penalties for Drug Offenses in Pennsylvania

Pennsylvania enforces strict penalties for drug offenses, which can vary based on the specific offense, the type and quantity of the controlled substance, and an individual's prior criminal record. Common penalties include:

**Fines:** Convictions for drug offenses can result in substantial fines, which may amount to thousands of dollars.

**Probation:** Some individuals may be sentenced to probation, requiring regular check-ins and compliance with court-ordered conditions.
